

For the license types below you can currently search, apply for a new license, pay or renew your existing license:

- **For-Hire OPERATOR License**, A For-Hire Operator is any entity or individual operating as a taxi or transportation network company.
- **For-Hire VEHICLE (TAXI) License**, A For-Hire Vehicle (TAXI) are the vehicles used for the transportation of passengers for compensation.
- **For-Hire DRIVER License**, A For-Hire Driver is a person that drives a for-hire vehicle in affiliation with a for-hire operator for compensation.

- **Amusement Device License** An amusement device is a mechanical or electronic device designed to be played or operated by the insertion of a coin or token, or otherwise upon payment of a fee, for the purpose of amusement, entertainment or music.

- **Entertainment Facility License** An entertainment facility is any business, club, or location where concerts, dances, carnivals, circuses, teen club, all ages venue, or a cabaret are presented to the public as a regular course of doing business.

- **Commercial Tree License** Any person or entity hired to prune, plant, or remove a public tree, as defined in SMC 12.02.945 or street tree as defined in SMC 12.02.952 must be licensed to perform commercial tree work in the City.

- **Temporary Business Registrations** Available for businesses located outside the City of Spokane that conduct business in the City on a temporary basis. Each license is issued for a period of ninety days.

• **Itinerant Vendor Permit** An itinerant vendor permit is for those that travel from door to door, selling from roving vehicles, or engaging in business in the City with no permanent location. Does not apply to Mobile Food Vending except when the vending unit is a very small pushcart (twenty cubic feet of cart or less).

• **Charitable Solicitation Permit** To “solicit” means to request money, credit, goods merchandise, time or other assistance, financial or otherwise, upon the representation that it will be used for charitable purposes.

• **Mobile Food Vendor Permit** A mobile food vending means a readily movable food service establishment such as a push car, van trailer, or a temporary/movable structure approved for mobile food vending by Spokane Regional Health District.
